Open to individuals working in all media.

ENTRY DEADLINE:

Saturday, May 21st, is the final date for submission of this application form and liability waiver (below), along with a description and photo of the entry, to osacreations@yahoo.com

Pieces may be dropped off at the OSA office **between 9:00 AM and 3:00 PM, from Monday, May 22nd through Friday, May 27th**, and at other times that week by contacting Mark Hill at osacreations@yahoo.com.

TO APPLY:

Please submit the following:

- 1) A completed application form and liability waiver. All entries are displayed at your own risk; OSA and *Creations Art Show* are not liable for the safety of your pieces, but will make every effort to preserve them.
- 2) A description and photo of the entry, giving dimensions. We need to know if an entry is to be hung on the wall, placed on the floor, or other, so we can properly display your work.
- 3) If you are performing, we need to know how many performers, and any special requirements you would have. (We can provide a single wireless microphone; we have in-house speakers and an in-house computer projector, and a stage area.) Performances will be scheduled in as mutually agreeable a manner as possible on either or both of two Saturday evenings, but final decisions rest with the staff of *Creations Art Show*.
- 4) Multiple submissions are possible, but only as space allows, and solely at the discretion of the staff of *Creations Art Show*. We will inform you ASAP how many of your pieces can be accommodated.
- 5) **Each entry, whether physical or performance, must also be accompanied by an artist's statement describing how the piece represents your experience with Joy.** The description can be as long as you want, but the staff of *Creations Art Show* reserves the right to edit for space reasons.

GUIDELINES:

All entries intended to be hung must be fully ready for hanging. **Our hanging system uses a hook suspended from a cable; framed works need a wire or string attached to both sides of the frame to hang from.** We welcome oversized pieces as space is available.

- Pedestals are not available for free-standing pieces—if required, artists will need to bring their own. Deep window sill space is available.
- After the show ends, all pieces can be picked up between the hours of 9 AM to 3 PM, Monday through Friday. For alternative arrangements, please **contact Mark Hill** at osacreations@yahoo.com. No pieces can be picked up before the end of the show without prior approval.

It is not our desire to judge your interpretation of Joy. However, our goal is for this to be a bridge-building exhibition, and extreme pieces may be deemed inappropriate. All possible accommodations will be made, at the sole discretion of the *Creations Art Show* staff.

SALES:

If you should sell any of your work(s) on display, the entire proceeds are yours. Neither *Creations Art Show* nor OSA will expect any commission or percentage. Your name and contact information (but not prices) will appear in the free program.

Performance pieces will be scheduled for the evenings of Saturday, June 4 at the opening reception, and/or Saturday, June 19 at the closing reception.

- I agree both, not to sue, nor to hold OSA, their directors, officers, employees, agents, and volunteers responsible for any loss, theft, or damages connected with registrant's participation in the exhibition.
- I understand that the release is intended to protect OSA, their directors, officers, employees, agents, and their volunteers from any claim of negligence (the failure of reasonable care).
- I understand that this is a release from liability, a hold-harmless agreement, and an assumption of risk agreement.
- I understand that this is a binding agreement between OSA and me, and that it is binding on me, my heirs, or anyone making a claim.

- I understand that the Curator has the final authority regarding acceptance of all work into an exhibition and its placement within the exhibition space of OSA. The Curator will endeavor to inform all artists of final decisions regarding placement of accepted work but reserves the prerogative to make any last minute changes to the exhibition and placement of work to ensure maximum artistic impact. This may result in changes being made which may not be communicated to the artist prior to the opening of the show.
- I understand that all accepted work into any exhibit will remain on display for the duration of the exhibit unless otherwise determined by the Curator.
- I give OSA permission to photograph my work and if desired, use the photos in print or electronic media for the promotion of their programs and future art exhibitions.
